

# **Patient Journey Checklist**

## **Hip / Knee Joint Surgery**

#### **Day of Surgery**

Your surgery is at Juravinski Hospital on	(date). Arrive 3 hours before your
surgery time or if your surgery is at 0800, arrive at 0600. The morni	ng of your surgery, go to Entrance
A (Main Entrance). Go to Patient Registration on the first floor (be	nind the information desk) where
you will be instructed of next steps.	

#### **Important reminders**

- ✓ Bring your Health Card.
- ✓ Please have no more than 1 or 2 adults with you.
- ✓ At home take a shower with soap and shampoo your hair. Dress with freshly washed clothes. Sleep in freshly washed bedsheets. Do not shave the area of surgery unless instructed.
- ✓ Use the scrub sponge (soft part) you bought, on the side of your body you are being operated on. Refer to the "Instructions for showering with Chlorhexidine sponge New hip and knee surgery" sheet for details on how to use. Bring clean clothes to wear to the hospital.
- ✓ Remove all jewelry (including wedding bands) and body piercings and nail polish. **Jewelry and** piercings that cannot be removed will need to be cut off by a jeweler before surgery.

### **After Surgery**

From the Operating Room, you will be moved to the **Post Anesthetic Care Unit (PACU)**, you may have:

- an oxygen mask put on your face
- an oxygen monitor on your finger to check the oxygen level in your blood
- your blood pressure, pulse and respirations checked every 5 to 15 minutes
- your incision checked often

From PACU, if you are a **Same Day Admit**, you will be sent to the **Arthroplasty Unit (AU)**. If you are a **Same Day Home** discharge you will stay in PACU or be sent to Same Day Surgery, the same place you were preoperatively, where a nurse and physiotherapist will see you to discharge you home.

#### **Discharge to Home**

If you wish to have support virtually when you are at home; you may wish to enroll in the Surgical Transitions **Remote Monitoring program (RPM). See reverse.** 

**Respite care** and **PSW/nursing** support is arranged and paid by **YOU** the patient. These services should be arranged **PRIOR** to your surgery date.

#### Once you meet discharge criteria:

- You must have an adult drive you home from the hospital who will bring your walker.
- You will be given a Bundle Care letter (blue colored letter) of instructions of payment to your Physiotherapy service provider. You MUST bring this letter along with the physiotherapy prescription to your first physiotherapy appointment.





# **Surgical Transitions Remote Monitoring Program**

**Patient Information Sheet** 

The Surgical Transitions Remote Patient Monitoring (RPM) is a collaborative initiative that provides patients with technology to use at home, which enables a healthcare provider to monitor vital signs and symptoms remotely.



This program is intended for adults who have recently undergone a surgery at one of the collaborative partner hospital sites.



If you are a patient at Hamilton Health Sciences, a care team will determine whether remote monitoring is right for you. There is **no cost** to enroll in this program.



If you agree to enroll in Surgical Transitions RPM program:

- Prior to leaving the hospital, you will be provided with the devices to take home for the duration of the program
- You will be required to complete daily questionnaires and assessments using the tools provided
- You will be required to return the devices within three days of discharge from the program using the pre-paid shipping services that will be provided
