

SENIOR MEDICAL OFFICER – Quality, Patient Safety and Experience - McMaster Children's Hospital and Women's Health

Applications are invited for the positon of Senior Medical Officer – Quality, Patient Safety and Experience for McMaster Children's Hospital and Women's Health (SMO – MCH/WH). Hamilton Health Sciences (HHS) is seeking an outstanding individual with proven leadership experience, a commitment to continuous enhancement of Quality of Care and Patient Safety & Experience and an ability to transform care leveraging a strong collaborative foundation.

Role description

As the physician lead for the patient safety program at McMaster Children's Hospital (MCH: including the Ron Joyce Children's Health Centre) and the HHS Women's & Children's Health (W&CH) program, the SMO MCH/WH is responsible to support the oversight, implementation, and monitoring of the patient safety program, in collaboration with both MCH/W&CH Leadership and HHS Patient Safety. The SMO MCH/WH works together and in co-leadership with the Director/Manager of Patient Safety at the hospital and reports directly to the Executive Vice President Academic & CME, with a dotted line relationship to the President, MCH and Vice President, W&CH. As co-chair of the MCH/Women's & Children's Health Patient Safety Steering Committee, the role has accountability to report to the MCH/W&CH Executive Committee.

Responsibilities Include:

- Support the oversight and implementation of elements of the Solutions for Patient Safety for current and potential quality and safety collaboratives, in partnership with HHS Leadership.
- Active participation and understanding of the various quality improvement initiatives and networks that MCH is involved in.
- Regular participation in Critical Incident Reviews or Quality of Care reviews.
- Active participation in the weekly Serious Safety Event reviews.
- Active participation in the monthly Medication Safety review committee.
- Active participation in education sessions to promote patient safety knowledge and skill development.
- Co-chair of the MCH/Women's & Children's Health Patient Safety Steering Committee.
- Prepare to collaborate and present at meetings as needed.
- Promote a culture of commitment to quality and patient safety by developing related policies and procedures.

- Act as an expert resource to Senior Leadership, department managers, physicians, and other members of the health care team regarding quality/process improvement initiatives, data collection, and interpretation.
- Foster a climate of collaboration, knowledge exchange, openness, trust and communication to support high functioning teams.
- Support hospital/physician partnerships by assisting physicians to navigate systems to address concerns or provide feedback.
- Serve as liaison and champion with physicians when practice changes are being considered to enhance patient safety.
- Utilize quality indicators within the Epic EHR to drive quality improvement.
- Facilitate sharing of quality and safety data amongst the physician teams including residents, fellows and other medical team learners.
- Promote and model the SPS philosophies of all teach, all learn and the goal of zero harm.

The role is a 0.2 FTE equivalent, working in collaboration with the Senior Medical Officer - Quality, Patient Safety and Patient Experience.

- Demonstrated leadership using strong interpersonal, communication skills, and visionary abilities.
- Demonstrated knowledge of performance measurement, quality improvement and proactive patient safety principles and tools.
- Skilled at building and maintaining internal and external relationships at all levels, including networks and supporting partnerships.
- Demonstrated knowledge of Quality Frameworks, principles and implementation.
- Demonstrated knowledge of change management theories, principles and implementation practices.

The Senior Medical Officer will serve a four-year term which may be renewed for a second fouryear term.
